parking

With the metro or commuter train:

With the metro blue line it takes arouand 20 minutes from the Central station in Stockholm and around 15 minutes walk to the exhibition. With commuter train from Stockholm Central station 17 minutes to station Helenelund and from Arlanda airport around 20 minutes and 3 minutes





walk to the exhibition.

With car: Kistamässan is situated in direct connection to E4 and E18.

Fire Instruction

NB! All material in the stand must be fire proof.

There is an automatic fire alarm and the facilities are equipped with sprinklers. The alarm is directly linked to the Fire department and our smoke detectors are very sensitive. An exhibitor causing a fire emergency response by mistake will be charged any costs arising. If the alarm is triggered a siren howls, and a spoken message in both Swedish and English, will urge everybody to evacuate the facilities – the assembly point is the big parking

lot next to the highway.

Smoking and open fire is not permitted in the hall.

Insurance

We recommend that you take out a separate insurance for the trade fair – contact your insurance company and ask for a temporary trade fair insurance. NB!! Do not leave any valuable goods when you leave the stand

for the day, such as computers etc.

Disposals

For moving in and out, mobile environmental stations are placed in the halls, where all refuse is to be sorted. During fair days, the environmental stations may be found at the loading door. Exhibiting companies will be charged for the removal of refuse and any exhibited goods left behind.

Storage

There is space to use for storage of smaller goods and wrapping.

Remember

Bring pencils, scissors, tape, tools, extension leads, a trolley, string, cloths, etc. **Note!** Using nails, tape or adhesive pads is not permitted to use on the walls, floors or ceilings of the exhibition hall.

Internet

Free wifi available. Fixed connection for the Internet (For hire), Please order in good time – contact Mäss-Service.

Electricity and carpet

Please be reminded that electricity is not included in your stand. If you wish to use computers or other electrical equipment you have to order electricity.

There is a concrete floor in the hall.

Stand walls

Stand walls must be restored to their original condition, any damage will be





charged.

Cleaning Cleaning of the aisles and other common space is done by Kistamässan.

Exhibitors are responsible for cleaning of their own stand. Cleaning of the stand can be ordered with the technical order form from Mäss-Service.

Sound Please keep a moderate sound volume.

The stand With regards to evacuation it is not permitted to put goods and products

outside the stand. It is not either permitted to expose bulky products on the

outside of the stand walls.

Food and beverages in

the stand

The restaurant in Kistamässan has the food and alcohol permission which

means that distribution of food, drinks of the like is not allowed.

You can order this in advance from the restaurant.
